

Urban context in the EU (2)

- 70% of the population live in cities, towns and suburbs
 -> Over 300 million Europeans
- Urbanisation is continuing
 -> expected that urban areas will be home of 80% by 2020
- 60% of public investments takes place at sub-national level
- Cities and town are crucial in achieving the EU's smart, sustainable and inclusive objectives
- Also small and medium-sized towns matter (66% of EU urban population lives in urban areas <500 000 inhabitants)</p>






a) Earmarked funding Amount allocated to ERDF Article 7

a) Earmarked funding Programming results Article 7 (1)

ERDF allocation of approx. EUR 15 billion in 110 programmes

 \geq 8% of the total ERDF allocations.

Variation on the share of ERDF allocated

- 3 Member States: 15-21% of ERDF
- 11 Member States: 7.5-11% of ERDF
- 14 Member States: 5-6% of ERFD

Half via ITI; the other half via a priority axis and 4 urban programmes

Policy

DG REGIO expects 500 to <u>800</u> cities to be involved.



a) Earmarked funding Programming results Article 7 (2)

Thematic focus within sustainable urban development

- ▶ 50% on shift towards low carbon economy (incl. energy efficiency, renewable energies, sustainable urban mobility)
- 20% environment (incl. brownfield regeneration, air pollution)
- ▶ 20% on employment, poverty and social inclusion (incl. regeneration of deprived communities)





b) Delegation of responsibilities

Urban authorities <u>shall</u> be designated as intermediate bodies

> At least responsible for selection of operations

Written agreement and appropriate procedures to be in place





Building blocks

- > Relevant targeted area
- > Partnership
- Local Development Strategy and Action Plan
- Financial resources concentration
- > Capacity Building & Networking





Principles (1)

- Comprehensive addressing social, economic, environmental, climate and demographic challenges
- Built on a robust territorial analysis
- Integrated part of a wider strategy
- Mid-term or long-term vision



Principles (2)

- Not only focusses on the use of ERDF and other EU financial resources
- Use ERDF and ESF in synergy
- Be realistic taking into account capacity to implement and resources available
- For the use of ESI Funds linked clearly to specific objectives of the programmes and priority axes





Added value

- Responding to local needs and priorities across sectors
- Spur local initiative, entrepreneurship and innovation
- > Improve governance at local level
- Better impact and sustainable results through partnerships and ownership

Urban innovative actions

Objective: to identify and test innovative solutions to key urban challenges

- Budget: EUR 370 million (2015-2020)
- Projects max. 3 years; ERDF grant max. EUR 5 million; Co-financing max 80%
- Topics linked to Urban Agenda annually set by EC
- First call for proposals planned end 2015; one each year
- Proposals to be assessed based on: Innovative nature of idea, Scope of partnership, Measurability of results, Transferability of the solution, Quality of the proposal



Objectives: Capacity-building, networking and Exchange of experience at EU level

- Support cities in the implementation of Article 7 and 8
- Develop and promote an integrated approach to urban development
- Create a platform of two-way knowledge exchange between cities, MA-MS and Commission
- Mainstream knowledge generated in URBACT networks

Tools: Workshops, Specific working groups, peer reviews, study visits, websites, studies and expert work


4 main objectives

- To <u>improve the capacity</u> of cities to manage sustainable urban development in an integrated and participative way.
- Policy Design: To improve the design of sustainable urban policies and practices in cities.
- Policy Implementation: To improve the implementation of integrated sustainable urban strategies and actions in cities.
- Building and Sharing Knowledge: To ensure that practitioners and decision makers at all levels have access to knowledge and share know-how
